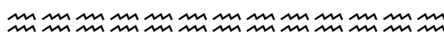

Children under the age of 18 must be accompanied by parents/guardians at all times – under certain circumstances this requirement may be waived - see note 2 overleaf.

**Additional notes:**

1, Keys will not be given to Young Members but are available to all other classes of membership subject to the payment of the Key Deposit.

2, A parent or guardian may apply for the relaxation to the 'accompanied child' rule if the child is over 12 years and has sailing experience and the parent has signed the Club formal waiver declaration (applies to Sunday racing or open meetings and other organised events where supervision is provided only). This form is available from the Membership or Club Secretary on request. It also applies to Young Members and children within Family memberships.

3, If Boat Berth Fees remain unpaid by the 31<sup>st</sup> March the subscription will be considered to be three months overdue and the club may remove the boat from the Berth and locate it elsewhere on the site. Other actions are detailed in the constitution section 12.

4, Boats belonging to Non Sailing Members will be located to the rear of the dinghy park, once that area is full they will be allocated spaces in the main park
